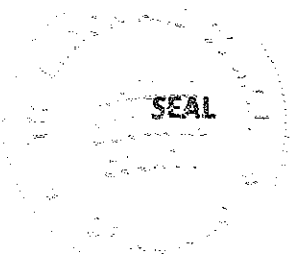

EXECUTIVE SESSION (employee matters) – started executive session 5:30 pm.

- 1. Call Meeting to Order – Lee called to order @ 6:04 pm.**
- 2. Invocation – Jeffrey Floyd**
- 3. Pledge of Allegiance**
- 4. Approve minutes from 12/19 Regular Meeting – Cox made the motion to approve the minutes, Jones 2nd, unanimously approved.**
- 5. Approve Agenda – Woodard made a motion to approve the agenda, Cox 2nd, unanimously approved.**
