- **Server Replacement Quote:**

A quote was received from Plenus for a new server to replace the existing 9+ year-old server.

Motion made by Council Member Woodard to approve the purchase, seconded by Council Member Villegas.



Motion made by Council Member Villegas to adjourn the meeting at 6:37 PM, seconded by Council Member Geter.


